BACKGROUND:

The State is required to reach agreement with the Secretary of Labor on state-level performance goals for WIA Adult, Dislocated Worker, and Youth Programs. In addition, WIA Section 136(c)(2) states that the Local Workforce Investment Board (LWIB), chief elected official, and the Governor shall negotiate and reach agreement on the local levels of performance. Working in collaboration with the California Workforce Investment Board, the Employment Development Department's Workforce Services Division has been delegated the responsibility for the negotiation of the State and local performance.

POLICY AND PROCEDURES:

This directive provides the final LWIA performance goals for the Adult, Dislocated Worker, and Youth Programs for PY 2011-12. The LWIA's Youth performance goals are the same as the State levels. The Youth goals were not negotiated for PY 2011-12 at the individual LWIA's level.

ACTION:

This directive should be brought to the attention of Program Administrators and staff, and the LWIB.
