SUBJECT: REA INTERVIEWS FOR FEDERAL UI EXTENSIONS—2013 PROGRAM

This Information Notice informs the Workforce Development Community that Reemployment and Eligibility Assessment (REA) interviews will resume January 28, 2013, for Unemployment Insurance (UI) claimants to receive extended Emergency Unemployment Compensation (EUC) benefits.

As you know, President Obama signed the American Taxpayer Relief Act of 2012 (H.R. 8) on January 3, 2013. In part, the bill extends the requirements of the Middle Class Tax Relief and Job Creation Act of 2012, which provided extended benefits to UI claimants and mandates states to conduct REA-EUC interviews. The interviews will be carried out at 81 One-Stop Career Centers throughout the State (see Attachment I) through December 28, 2013.

Notification to affected claimants began in mid-January. Claimant responsibilities remain the same as those required during the 2012 REA-EUC program. Claimants will be pre-scheduled for an appointment at an assigned REA-EUC site, undergo a UI eligibility assessment reviewing their work search efforts, receive an orientation to One-Stop Career Center services and labor market information, and complete an online skills assessment. While the interview must be conducted in person and the additional activities will be available at the One-Stop Career Center, the orientation, skills assessment and labor market information may be viewed online at [www.edd.ca.gov/REAEUC](http://www.edd.ca.gov/REAEUC) prior to attending the in-person interview. Failure to attend an REA-EUC interview may affect the claimant's eligibility to receive EUC benefits.

The Department of Labor recommends that One-Stop Career Center partners enter into a Memorandum of Understanding (MOU) to strengthen the collaborative efforts in serving REA-EUC claimants. The MOU ensures that UI claimants have access to the full array of reemployment and training services at One-Stop Career Centers. The State of California is requiring Workforce Services offices and the One-Stop Career Center partners to enter into a MOU that is specific to the REA-EUC program. Attachment II is an example of a MOU that may be used or adapted for this purpose.

**MEMORANDUM OF UNDERSTANDING  
REEMPLOYMENT AND ELIGIBILITY ASSESSMENT - EMERGENCY  
UNEMPLOYMENT COMPENSATION PROGRAM**

**Parties to the Agreement**

This Memorandum of Understanding (MOU) is a cooperative agreement between the Employment Development Department (EDD), the One-Stop Career Centers and partnering agencies identified as providing Reemployment Eligibility Assessments-Emergency Unemployment Compensation (REA-EUC) and specific related services to selected Unemployment Insurance (UI) claimants. This agreement ensures that the necessary partners commit to providing reemployment services above and beyond minimal service levels, including referral to any reemployment services that are deemed necessary to assist UI REA-EUC claimants return to suitable employment.

**Period of the Agreement**

This agreement is effective January 2, 2013, through December 28, 2013.

**REA-EUC Program in California**

This MOU supports the vision for California as outlined in Training and Employment Guidance Letter (TEGL) 20-11, Reemployment Services, and Reemployment and Eligibility Assessment Activities for Recipients of Emergency Unemployment Compensation. California operates the REA-EUC program in One-Stop Career Center offices and has fully integrated the program with Workforce Investment Act funded services. All claimants have access to the full array of services available at the One-Stop Career Centers while also ensuring claimants comply with all UI eligibility requirements.

**Roles and Responsibilities**

The EDD and the One-Stop Career Centers must coordinate reemployment service needs to provide the following services:

- Orientation to help claimants access self-service core services offered by the One-Stop Career Center through the resource room or online, with particular emphasis on accessing available labor market and career information;
- Registration with CalJOBS<sup>SM</sup> (California's job bank); and
- Referrals to appropriate services offered through the One-Stop Career Center.

All undersigned parties agree to provide appropriate reemployment services to recipients of emergency unemployment compensation.
