2. \_ Your request to receive payment on an unemployment insurance (UI) claim based on an Alternate Base Period is denied. You do not have enough wages in the Alternate Base Period to establish a valid claim. You requested to file a claim for benefits with a benefit year beginning / / . Under the Alternate Base Period program the base period of your claim is / / to / / . Unemployment insurance benefit awards are computed on wages paid in the base period per section 1275(b) of the California UI Code.

10. \_ You reported that you were employed as an independent contractor, not as an employee with . After considering the available information, the Department finds that you were an “employee” per section 621B of the California Unemployment Insurance Code.
10. \_ Koj qhia tias koj yog ib tug muaj ntawv cog lus ua hauj lwm rau koj tus kheej, tsis yog ib tug “ua hauj lwm” rau . Tom qab Chav Tuam Tsev mam rhiav tau tias koj yog ib tug “neeg ua hauj lwm” raws li Xeev Kaslifausnias txoj kevcai lijchoj nqi 621B.
11. \_ Your request to file an unemployment insurance (UI) claim beginning / / based on an Alternate Base Period is denied because you qualify to file a Standard Base Period claim. Pursuant to section 1275 (b) of the California UI Code, the Alternate Base Period can only be used to file a UI claim when there are not enough wages earned in the Standard Base Period to file a monetarily valid UI claim.

12. \_ Your request to file an unemployment insurance (UI) claim based on the Alternate Base Period (ABP) effective / / is denied. Pursuant to section 1275 (b) of the California UI Code, the first date an ABP claim can be filed is 04/01/12.

Yog koj xav tias kev txiav txim siab tsis yog lawm, koj ua daim ntawv rov mus hais dua nyob ntawm qhov chaw uas muaj nyob saum daim tob hau ntawv no los tau. Nyob hauv koj daim ntawv rov hais dua no, piav seb yog vim li cas koj thiaj tsis pom zoo raws li qhov kev txiav txim siab no. Qhov rov hais dua no, yuav tsum ua kom raws caij raws nyoog, yuav tsum ua uantej los yog lub / / no.

Important:

While an appeal is pending, you must continue to submit claim forms for each week you wish to be paid. If the final decision holds you eligible, you will only be paid for those weeks for which you have filed claim forms and have met all eligibility requirements.
