As the Director of the California Employment Development Department (EDD), I am pleased to tell you about the wide variety of services and programs that the EDD provides to California employees and their employees.

TAX BRANCH: The EDD Tax Branch administers the accounting, auditing, and collection functions of California's payroll tax program to support and fund the state's Unemployment Insurance (UI) and State Disability Insurance (SDI) programs. We provide many tools and resources to assist you in meeting your California payroll tax responsibilities. e-Services for Business: Managing your employer payroll tax account online has never been easier. Enroll in e-Services for Business to file your employment tax returns and wage reports, make payments, or view and update your account information. UNEMPLOYMENT INSURANCE: What happens when a former employee files for UI benefits? When a new claim is filed, or an existing claim is reopened, you will receive a *Notice of Unemployment Insurance Claim Filed,* DE 1101CZ. The EDD relies on employers to respond to this notice in a timely manner to help determine a claimant's eligibility for UI benefits and to accurately charge an employer's reserve account. Employers and third-party administrators can elect to receive and respond to this notice electronically by subscribing to the State Information Data Exchange System (SIDES) at **www.edd.ca.gov/SIDES**.

If additional eligibility or wage information is needed, the EDD will contact you by mail or by phone. Your timely response will help protect your UI reserve account.

STATE DISABILITY INSURANCE: State Disability Insurance (SDI) is an insurance program that provides a portion of California workers' pay when they are unable to work. It is required by law and funded by California workers through payroll deductions. The SDI program provides two benefits: Disability Insurance (DI) and Paid Family Leave (PFL). DI benefits help employees who are unable to work and lose wages due to a non-work-related illness or injury, or due to pregnancy or childbirth. PFL provides benefits to employees who take time off work to care for a seriously ill family member or to bond with a new child. The EDD offers an optional Disability Insurance Elective Coverage (DIEC) for employers and self-employed individuals who are not required to pay into SDI but want to be covered by DI and PFL. DIEC is funded through quarterly premiums and can protect you against partial loss of income when you are unable to work.

When an employee has filed a DI or PFL claim, you are legally required to respond to the EDD within two days of receiving a notice. You can use SDI Online to receive electronic notifications when your employees file a DI claim. Save time and postage by responding online. For more information or to register for an online account, visit **www.edd.ca.gov/disability**.

WORKFORCE SERVICES BRANCH: The EDD Workforce Services Branch (WSB) provides employment services through CalJOBSSM to help your business succeed. The WSB also provides re-employment services to displaced workers and conducts recruitment campaigns for businesses with specialized needs. WSB no-cost services for employers include assistance with recruiting and screening of job applicants, employee training, job fairs, and coordinating workshops. We can also provide information on fidelity bonding and tax credit incentives. In partnership with local Employer Advisory Councils, we offer informational seminars to keep you current on employment-related laws and regulations.

CalJOBSSM: Register with CalJOBSSM and use the virtual recruiter 24 hours a day, 7 days a week, to find qualified candidates, post job openings, browse through thousands of résumés of potential employees, research the labor market, and much more. Visit CalJOBSSM at **www.caljobs.ca.gov**.
