



## Cannabis Industry Payroll Tax Reporting

The Employment Development Department (EDD) is here to help business owners in the cannabis industry comply with California's payroll tax laws and avoid unforeseen tax liabilities. If you hire employees to perform services, you are required by law to withhold, report, and pay payroll taxes to the EDD.

Cannabis businesses include, but are not limited to:

- Distributors
- Transporters
- Dispensaries, which would include:

- Employees
- Plant caretakers
- Budtenders
- Security guards
- Salespersons
- Deliverers

## Semi-Annual Interest Rate Reporting

The interest rate is adjusted semiannually based on the short-term federal rates in January and July of each year. Interest is charged on all delinquent taxes, interest, and certain penalties. The interest rate is established according to section 19521 of the California Revenue and Taxation Code.

For the period July 1, 2019, through December 31, 2019, the semi-annual interest rate will be 6 percent (0.06), compounded daily. The daily interest factor will be 0.000164.
