NEW STATE LAW: *Electronic File and Pay Requirement*

Beginning January 1, 2017, California state law, Assembly Bill 1245, requires employers to electronically submit employment tax returns, wage reports, and payroll tax deposits to the Employment Development Department.

- Effective January 1, 2017, employers with 10 or more employees are required to electronically file and pay.
- Effective January 1, 2018, all remaining employers are required to electronically file and pay.

What is e-Services for Business?

e-Services for Business is a fast, easy, and secure way for employers, employer representatives, and payroll agents to manage an employer payroll tax account online 24 hours a day, 7 days a week, at no cost.

Features:

- Register for an employer payroll tax account number.
- File employment tax returns/wage reports.
- Make payments.
- View, adjust, and print tax returns/wage reports.
- View and update account information.
- View current and past three years payroll tax rates.
- Close or reopen an employer payroll tax account.
- Subscribe to the State Information Data Exchange System (SIDES) to electronically receive and respond to the *Notice of Unemployment Insurance Claim Filed*, DE 1101CZ.
