DE 1275A包含的上述各項主題適用於工作分擔參加者。例如

- 提交每項失業保險申請後都有一段等待期,包括工作分擔福利申請在內。
- 不論您是否為工作分擔參加者,撤銷失業保險申請的程序都相同。

提出您的失業保險申請後,將寄送 Notice of Unemployment Insurance Award, DE 429Z (失業保險發放通知)以及 Unemployment Insurance Benefits: What you Need to Know, DE 1275B (失業保險福利:您需要知道什麼)。這些通知僅與一般失業保險申請有關。請保留這些資訊作為您的記錄。

仔細閱讀所有資訊,並且保存作為日後查閱。如果提供的資訊沒有回答您的問題,或是您需要幫助,請透過以下的號碼聯繫就業開發署。

Employment Development Department Special Claims Office PO Box 419076 Rancho Cordova, CA 95741-9076 916-464-3300 工作分擔計劃幫助雇主和員工避免在生意不景氣時期裁員。為此,您的雇主將把您每週的工作時間和工資至少減少10%,但不超過60%,同時不調低時薪。工作分擔福利按照工時和工資的減少比例支付。例如:

您的工作分擔計劃雇主把您正常的每週工作時間從40小時減到32小時。付給您的時薪為每小時10美元。由於工作分擔,您正常的每週工資從400美元減到320美元。這意味著您的工作時間和每週賺取的工資都減少20%。

由於您的工作時間減少20%,您賺取的工資也減少20%。每小時10美元的時薪保持不變。

雇主將決定哪些員工參加工作分擔計劃,以及在哪些週減少工作時間和工資。

雇主的工作分擔計劃獲得批准後,就業開發署 (EDD) 會將每位參加員工的「資料包」寄給雇主。當雇主決定減少某一週的正常工作時間時,將發給每位被選中參加工作分擔計劃的員工一個資料包。每個資料包中含有提出失業保險申請必需的所有文件。除DE 1275WS手冊外,資料還包括以下各項:

Initial Claim and Payment Certification, DE 4511WS (初次申請及支付證明) 您的雇主將填寫A部分,並把 Initial Claim and Payment Certification,DE 4511WS (初次申請及支付證明) 發給您,讓您填寫B和C部分。在您的雇主填好A部分之前,請勿填寫B和C部分。

兩個印有特別理賠辦公室地址的信封

這些信封是供您寄送下兩份的 Work Sharing Certification, DE 4581WS (工作分擔證明)。用完這些印有地址的信封後,您要自行負責把工作分擔證明及時寄到特別理賠辦公室的正確地址。

NOTICE OF UNEMPLOYMENT INSURANCE AWARD, DE429Z (失業保險發放通知)

您提出申請後,將寄給您一份 *Notice of Unemployment Insurance Award*, DE429Z(失業保險發放通知)。請仔細檢查該通知。欲瞭解關於DE 429Z的更多資訊,請瀏覽www.edd.ca.gov的「表格和出版物」(Forms and Publications)頁。

通知中有您這次領取的每週和最高福利金額。每週福利金額是您*完全*失業時應付的*每週全部*金額。將根據您每週減少的工作時間和工資的百分比,支付工作分擔福利。例如:

- 如果您每週的全部福利金額是230美元,而且您每週的工作時間和工資減少10%。
- 您將領到230美元的10%(工作時間和工資減少10%),即23美元

如果DE 429Z中的資訊有誤,請儘早聯繫特別理賠辦公室,因為您領取的福利金額可能會有誤。

有關工作分擔計劃的問答

問:由誰支付工作分擔福利的費用?

答:工作分擔失業保險是由您的雇主出資的保險計劃。不會從您的工資中扣除任何 錢來支付這些福利。

問: 我如何知道我將獲得多少工作分擔福利金?

答: 在您遞交失業保險申請之後,將寄給您一份DE 429Z。通知上寫明您的每週福利金額。將根據您每週減少的工作時間和工資,向您支付該金額的一定比例。例如:

如果您每週的福利金額是230美元,而且您每週的工作時間和工資減少10%,將向您支付230美元的10%,即23美元。如果您每週的福利金額是150美元,而且您的工作分擔時間和工資減少30%,將向您支付150美元的30%,即45美元。

問:我能撤銷申請嗎?

答: 寄給您DE 429Z之後,您可以選擇撤銷工作分擔加州失業保險申請。您僅可在沒有支付福利,沒有寄給您喪失資格通知書,及(或)沒有確定超額領取的情況下,才可撤銷失業保險申請。如果申請被撤銷,將不能重新開立,但您可在日後提出新申請。如果初始申請未被撤銷,52週內不能提出其他加州申請。如果您有關於申請撤銷的問題或是想撤銷您的申請,請聯繫EDD。

重要:申請一旦撤銷,不能在同一起始日重新建立。

- 問: 會從我的工作分擔福利中預扣聯邦稅嗎?
- 答:如果您希望預扣申請表上寫明週數的聯邦所得稅,請填寫申請表上的回答欄。 如果您不想要預扣稅,則將此欄留白。這個選擇完全自願;並未規定您必須從 福利中預扣稅。
- 問:工作分擔計劃的參加者需要一週的等待期嗎?
- 答: 是的,加州法律規定每個人完成經歷沒有福利的一週等待期。在每個52週的申請年度,只有一個等待期。等待週通常是您的福利年度中本可領取福利的第一週(本可領取意指若不是由於等候期的要求,您在各方面應當有資格領取福利)。
- 問:如果我遭到資遣,我還能使用工作分擔申請嗎?
- 答: 如果您遭到資遣連續三週以上,特別理賠辦公室將寄給您有關您的福利說明和 資訊。您的申請在一年內有效,並可在參加工作分擔計劃期間使用,或是用來 領取全部或部分的失業保險福利。領取全部或部分的失業保險福利期間,您的 申請將適用失業保險(而非工作分擔計劃)的一般規定。請參考DE 1275A和 DE 1275B。
- 問:由誰負責把工作分擔證明寄給特別理賠辦公室?
- 答: 由您負責把工作分擔證明寄給特別理賠辦公室。然而,有些雇主替員工把填好的證明寄給特別理賠辦公室。不論由誰寄出,證明都必須在雇主給您簽發的日期之後14天內蓋上郵戳寄出。
- 問: 我的雇主何時給我工作分擔證明?
- 答: 您的雇主會在您減少工作時間和工資的那第一個星期結束後,給您簽發工作分擔證明。證明必須在工作分擔週結束之後14天內簽發。
- 問: 我應當打電話給誰查詢是否已經發放福利?
- 答: 請等待10天再向EDD查詢您的付款。如果10天之後您還沒有收到付款,您可以 打電話給EDD的自動電話1-866-333-4606。如果自動電話告知您付款已發放, 請聯繫特別理賠辦公室,電話是916-464-3300。
- 問:如果我的借記卡遺失或被盜,應該怎麼辦?
- 答: 立即撥打1-866-692-9374聯繫美國銀行 (Bank of America)。

- 問:如果我沒有上班,我的工作分擔福利是否受影響?
- 答:如果您沒有上班而且您的缺勤沒有得到批准,或是您不能接受您的工作分擔雇 主分配給您的所有工作,您的福利可能會受影響。
- 問: 我是否可以為我的工作分擔雇主之外的其他雇主兼差?
- 答:可以,但是任何來自您的工作分擔雇主之外的其他雇主的工資收入,將如數從您的工資分擔福利中扣除。請仔細填寫您的證明表格,並寫明任何來自您的工作分擔雇主之外的其他雇主的工資收入。如果沒有包括來自您的工作分擔雇主之外的其他雇主的工資收入,可能會收回向您超付的金額並處以罰金。EDD有欺詐偵測系統。如果您沒有申報工作週的所有工資收入,但是領取了福利,您將受到調查。如果EDD認定您不申報工資收入構成欺詐,將要求您退還超付的福利,而且您可能面臨行政和(或)刑事處罰及利息。

問:如果我被拒絕工作分擔福利,能怎麼辦?

答: 您可以就EDD的任何書面決定提出上訴。您必須書面提出上訴,並寫明您不同意決定的理由。您可以將填好的*Employment Development Department Appeal Form*, DE 1000M(就業開發署上訴表)或信件郵寄給「決定通知書」上的地址,提出上訴。上訴信必須寫明您的姓名、社會安全號碼以及您不同意決定的理由。

從決定之日起,您可以在30天內提出及時上訴。即使您錯過30天的最後期限,您仍可上訴。您必須寫明您的上訴為何延誤。上訴時,將要求您表明延誤上訴的合理原因。如果沒有表明延遲30天以上的合理原因,行政法官可能駁回您的上訴。

上訴辦公室將會通知您聽證日期、時間和地點。由一名行政法官執行您的聽證。聽證之前,您有權查阅檢查影響上訴的所有記錄。每個人都會宣誓作證。 所有證言都會被記錄,並可能接受交叉質詢。行政法官將會郵寄裁決。如果您 住在其他州,上訴聽證將透過電話進行。您不必到加州參加上訴聽證。

如果您不同意行政法官的决定,您可以向加州失業保險上訴委員會提出上訴。

備註:如果您對喪失資格提起上訴,您必須在上訴待決期間繼續證明福利資格。您必須郵寄紙張的 Work Sharing Certification, DE 4581WS (工作分擔證明)。如果行政法官認定您有資格,將僅向您支付您做出證明並符合所有其他資格要求各週的福利。

填表說明 - INITIAL CLAIM AND PAYMENT CERTIFICATION, DE 4511WS (初次申請及支付證明)

Initial Claim and Payment Certification, DE 4511WS (初次申請及支付證明) 有英文和西班牙文版。您必須在您的工作分擔雇主給您簽發表格證明之日後14 天內填好證明,並寄給特別理賠辦公室。如果工作分擔雇主選擇為您將證明寄給 EDD,雇主也必須及時寄出。

填寫Initial Claim and Payment Certification, DE 4511WS(初次申請及支付證明)的B和C部分時,請遵循以下說明。(您開始填寫B和C部分之前,您的雇主必須填寫您的姓、名、社會安全號碼和A部分)。如果您對填寫B和C部分有任何疑問,請立即聯繫特別理賠辦公室。

INITIAL CLAIM AND PAYMENT CERTIFICATION, DE 4511WS (初次申請及支付證明) - B 部分(申請者證明)

問題 1. - 您是否為您的工作分擔雇主之外的任何人工作?(這包括自雇。) 在「是」或「否」一格打勾,以表示您是否為工作分擔雇主之外的任何人工作, 包括自雇。

*例子:*您從早上7點到中午12點為您的工作分擔雇主工作,並從下午2點到5點 為另一位雇主工作。這個例子的正確填法為「是」

例子:您在工作分擔雇主提供的工作時間內工作。您也在業餘時間做上門推銷員。這一例子的正確填法為「是」。

問題 1.a. - 如果是,填寫雇主的名稱、地址以及本週最後一個工作日的日期。

如果在問題**1**中的「是」打勾,填寫*第二雇主的名稱、地址和本週最後一個工作日的日期。如果您在為工作分擔雇主工作之餘自營業務,請在第二雇主名稱一行填寫「自雇」。

*當您參加一個雇主的工作分擔計劃,並同時為另一個雇主工作,提供另一份工作 的雇主視為*第二雇主*。

問題 1.b. -_填寫來自於自雇或其他就業在各項扣除之前的工資額,不論是否已支付給您。

填寫各項扣除之前來自第二雇主、自營業務或陪審任務的總工作收入,不論是否已 支付給您。根據表格上的起始和結束日星期,而不是根據第二雇主的支付期來申報 總工作收入。

問題 1.c. - 您是否繼續為該雇主工作?

在「是」或「否」一格打勾,以表明您是否繼續為該第二雇主工作,或是您仍然自 營業務或有陪審任務。如果否,寫明工作結束的原因。

(初次申請及支付證明) - B部分(申請者證明)

問題 2. - 如果您想預扣A部分所述星期的聯邦所得稅,請在此格打勾。

如果您在此格打勾,預扣金額將為該星期支付的工作分擔福利金的**15%**,但是將在減去所有規定的扣除金額或超額付款抵銷之後再扣減。例如:

工作分擔支付額: \$40.00 支付額的百分之十五: \$6.00 您得到的付款: \$34.00

如果您沒有在此格打勾,將不會預扣福利的任何聯邦所得稅。不論您做何決定,您的選擇的有效期僅持續到您寄出下一張證明表格為止。

請仔細閱讀證明資料。在證明上簽名並寫上日期。(簽名必須是原件,複印的簽名不予接受。)

問題 7. - 您是否持有駕照或身份證?回答是或否。如果是,請填寫發證州名以及您的駕照或身份證號碼。

(初次申請及支付證明) - C部分(申請者資訊)

問題 8. - 您是否為美國公民或國民? 回答是或否。

如果否,回答以下問題:

- a. 您是否在美國公民與移民局(USCIS,前稱INS)登記並獲授權在美國工作?回答是或否。
- b. 您的USCIS證件名稱是什麼? 在適當方格打勾。
- c. 請填寫您的文件上的外國人登記**或**授權號碼。

問題 13. - 您是否正在領取或是預計領取工傷賠償?回答是或否。

問題14.-選擇您首選的書面資料語言。選擇英語或西班牙語。

問題 **15.** - 選擇您首選的口頭語言。選擇英語、西班牙語或其他。如果您選擇其他,請填寫您的首選語言。

- 2. 在簽發日之後**14**天內,將工作分擔雇主簽發給您的任何證明表格提交特別理賠辦公室。
- 3. 是工作分擔雇主的正式員工。
- 4. 為工作分擔雇主做完正常(不減少工作時間或工資)的工作週之後,才參加工作分擔計劃。
- 5. 基本期季度的工資符合普通加州失業保險領取資格。欲瞭解有關基本期的 更多資訊,請參考www.edd.ca.gov上的DE 1275A。
- 6. 您的每週工作時間和工資必須最少削減10%,但不得超過60%。
- 7. 如果您從工作分擔雇主那裡辭職或被解雇,您將不再有資格享受工作分擔 福利。就業開發署將根據您的離職原因,決定您是否有資格享受普通失業 保險福利。

備註: 您的工資率沒有減少。您的每週工資減少10%,因為您的工作時數減少了10%。例如:

您的工作分擔雇主把您在正常工作週的工作時間從40小時減少到32小時。 您的時薪是每小時10美元。您每週的正常工資將因工作分擔而從400美元減少 到320美元。這樣,您每週的工作時間和每週所得工資均減少20%。

因為您的工作時間減少了**20%**,您的所得工資也減少了**20%**。您的時薪仍保持每小時**10**美元。

如果不符合上述標準,就不能領取工作分擔福利。如果您不符合領取福利的資格, 您將收到一份通知書,解釋您為什麼沒有資格享受工作分擔福利。通知書也將告訴 您有關上訴的權利。 您也必須申報來自您的工作分擔雇主之外的雇主的所有工作和總收入。必須申報所有工作和(或)工作收入,包括領取下列的付款類型。EDD將審計所有的失業保險福利,以偵測欺詐行為。如果您因為未向EDD提供正確資訊而領取福利,您可能被起訴並被拒付目前和未來的福利。
